

day 1: Friday, July 1, 2022

OVERNIGHT FLIGHT

Welcome GCTYO! Your curated performance tour begins with today's overnight trans-Atlantic flight to Europe from New York.

day 2: Saturday, July 2, 2022

TOLEDO/CORDOBA, SPAIN (D)

Arrive at Madrid's International Airport, where your full-time bilingual **tour managers** (one per coach) will greet you in the Arrivals Hall and welcome you to Spain! Begin explorations right away, as you board your private coaches and transfer to <u>Toledo</u>. Upon arrival, **local guides** will join you for a walking tour of Spain's old capital city to introduce you to the beauties of this ancient city. For centuries Toledo was home to one culture with three religious traditions, where Christians, Jews, and Muslims lived in relative harmony. Included are visits to Toledo's magnificent **cathedral**, the medieval **Sinagoga del Transito**, and El Greco's *The Burial of Count of Orgaz* at the **Santo Tome Chapel**. There is free time for lunch, before continuing to <u>Cordoba</u>, where you can settle in, relax, and enjoy **dinner** at the hotel.

day 3: Surday, July 3, 2022

CORDOBA, SPAIN (B/D)

Enjoy **breakfast** at the hotel this morning, and each day of your trip. The Andalusian town of Cordoba's glorious Moorish past is brought to life this morning by your **local guides**. You will visit the famous and remarkably

preserved **Mezquita** that dominates the old town. At its peak, it was the center of Western Islam and rivaled both Baghdad and Constantinople. The mosque was built on the site of a Roman temple, and is now a cathedral. Additional highlights include the Jewish quarter "La Juderia" to see the 14th century synagogue, and the Roman Bridge over the Guadalquivir River. There is free time for lunch to sample the region's fine tapas. This afternoon visit the ruins of **Medina Azahara**, a 10th century palace city built in the outskirts of Cordoba, by the first caliph of Al-Andalus, Abdar-Rahman III. **Prepare for your performance in Cordoba, with a two-hour rehearsal.** Dinner is served at a local restaurant. **Present your concert at a local venue, custom selected for the youth orchestra.**

day 4: Monday, July 4, 2022

SEVILLE, SPAIN (B/D)

Breakfast at the hotel. Depart Cordoba this morning, and journey to Seville, Spain's most flamboyant and atmospheric city. Lunch is under your own arrangements. Local guides will greet you upon your arrival, and lead your afternoon sightseeing tour. Beginning with the famous Plaza de Espana and its adjoining Maria Luisa's Park, you will then see the immense Cathedral of Seville. The third largest church in the world and burial place of Christopher Columbus, its "La Giralda" was originally a minaret and is now the Cathedral's bell tower. This evening, your tour managers will take you for a walk along the narrow streets of the picturesque Santa Cruz Quarter. This former Jewish quarter is filled with charming squares, cafes and gardens and is the perfect setting for dinner at a local restaurant with Flamenco entertainment.

day 5: Tuesday, July 5, 2022

SEVILLE, SPAIN (B)

Breakfast at the hotel. Begin the day with a morning guided tour of Alcazar palace, the Sevilla home of the Spanish Royal Family for the past 500 years. Originally a Moorish fort that later became a royal palace, you will be impressed with its fabled tile work. Enjoy a boat ride on the Guadalquivir River, the most important river in Andalusia. There is leisure time this afternoon for lunch and souvenir shopping with your tour managers.

Prepare for your performance in Sevilla, with a 90-minute rehearsal.

Dinner is under your own arrangements. Present your concert at a local venue, custom selected for the youth orchestra.

day 6: Wednesday, July 6, 2022

EVORA/LISBON, PORTUGAL (B/D)

Breakfast at the hotel. Your exploration of Portugal begins with this morning's journey toward the border. There is a stop in <u>Evora</u> for exploration of this delightful and historic university town. Enjoy a short walking tour with **local guides** to see the ancient Roman Temple of Evora (Temple of Diana), and free time for lunch. Travel through the Alentejo

countryside, and enter the city of <u>Lisbon</u> from the sweeping 25th of April Bridge—the largest suspension bridge in the world, and named for the Carnation Revolution of 1974 and Freedom Day. Check into your hotel and enjoy **dinner** at a local restaurant, or at the hotel.

LISBON, PORTUGAL (B)

Breakfast at the hotel. This morning's locally guided sightseeing shows you the sights and monuments of Lisbon's maritime empire, including stops at Belem Tower and the Monument to the Discoveries. See the Alfama district, Rossio Square and visit St. George's Castle, a Moorish castle overlooking the city from the millennium-old walls and commanding breathtaking views of Lisbon. There is free time scheduled for lunch today. Prepare for your performance in Lisbon, with a 90-minute rehearsal. Dinner is under your own arrangements. Present your concert at a local venue, custom selected for the youth orchestra.

day 8: Friday, July 8, 2022

SINTRA/LISBON, PORTUGAL (B/D)

Breakfast at the hotel. Feast your senses on the splendid scenery of Cape Roca and Sintra on a full day trip to the UNESC-listed village from Lisbon. Enjoy the coastline, and see the delightful fishing village of Cascais. You will also see the Bocca do Inferno cliff formations. Stop at Cabo da Roca, and enjoy the view from the westernmost point of Europe. Upon reaching Sintra, enjoy leisure time for lunch in the charming center. Portugal's rulers constructed extravagant palaces in the hills, and together with local guides you will visit Pena Palace. Tour this lavish construction of stone carvings and vivid color designed by King Fernando II. Return to Lisbon. This evening enjoy a dinner finale with Fado music entertainment.

day 9: Saturday, July 9, 2022

Breakfast at the hotel, before transferring to the airport for your return flights home to the United States. Your tour managers will assist with airport check-in, and there is time for one last goodbye.

ALTERNATE RETURN REQUEST

Would you like to stay in Europe at the end of your tour and continue traveling on your own?

We offer the option of changing your return airline ticket, to the date and gateway of your choice. We anticipate the summer season of 2022 to be very popular, and recommend that you make plans well in advance, to access the best flight and fare availability.

ALTERNATE RETURNS – are available at the end of a tour program. Print legibly in ink, and return this single page form a minimum of 120 days prior to your group's departure, and as early as possible to access the best flight and fare availability. Individuals who select an alternate return are responsible for their own ground transportation, beginning with the end of their group's tour program, and including return transfers to their newly selected airport.

AVAILABILITY – individuals may choose their new return date; alternate gateways are generally available to all destinations in Europe, but are dictated by the specific air contract of each tour program. Group flights must be confirmed prior to reviewing an individual's alternate return request.

FEES – a \$200 air deviation charge applies to any individual wishing to extend their stay, plus any applicable change in air fare related to your requested change. Air deviations are subject to availability of group rates.

GENERAL TERMS AND CONDITIONS

These terms and conditions explain a contractual arrangement between you and Kuoni Tumlare relating to the group booking. Any group booking made shall be deemed to be an offer by your agency to purchase the relevant accommodations and/or travel products subject to these terms and conditions.

General Terms

- Group pricing is based upon a minimum group size of 60 paying passengers. Should your group size fall below this minimum, we reserve the right to adjust your tour pricing.
- We reserve the right to adjust our tour price at any time before receipt of your final payment as a result of any of the following: (1) trade fairs; (2) a greater than 3% change in the relevant currency rates; (3) changes in government taxation or fuel surcharges.
- All personal incidental charges incurred by your clients must be paid directly to the supplier at the time of service.
- Coaches have limited capacity for luggage of 1 piece of standard airline baggage per person.
- Prices are valid only for a group transferring together in the same vehicle (unless otherwise indicated).
- In some cases, coach accessibility may be restricted at your destination.
- All necessary entrance documents (such as passports, visas, etc.) are the responsibility of the agent, group leader and/or individual travelers.
- Please advise if any travelers have special requirements. Any related arrangements are subject to availability and may incur additional costs.

Tour Planning and Payment Terms

• 95 days prior to departure: Final payment is due. Reduction of unsold space (blocked air reduced to actual group size)

- Any prepayments related to hotels, air fare, or other inclusions may be required in addition to the above mentioned amounts. A different schedule of deadlines, payments, and terms and conditions may apply.
- Payment must be made in the quoted currency 1) by bank transfer; 2) by check, 3) online by credit card (Mastercard or Visa, may be subject to an additional management fee). A fee of \$200 will be charged to all late final payments. A fee of \$100 will be charged for all returned checks.
- Organizations and participants are held liable for any and all credit card, bank transfer, and check payments, and agree to not dispute payments made in accordance with the agreed upon terms and conditions of your contract. In order to partake of the enjoyment and excitement of this tour, I am willing to accept the risks and uncertainty involved as being an integral part of my tour. I hereby accept and assume full responsibility for any and all such risks of illness, injury, inconvenience or death.

Liability and Indemnity

- •We shall not be liable for and shall be indemnified by you in respect of any loss (direct, indirect special or other consequential loss or damage) or third party claims (including any cancellation fees), whether based in contract, tort, negligence, strict liability or otherwise, that arises out of or is in any way connected with the performance or nonperformance by us or any supplier, or any accident, death or injury to person or property due to an act or omission by any hotel or other supplier providing or rendering services included in the booking.

Binding Arbitration

(JAMS). Such proceedings will be governed by substantive (but not procedural) Massachusetts law and will take place in Boston, MA. The arbitrator and not any federal, state, or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable.
